It is recommended that the participants arrive 15 minutes early.</li> <li>➤ The fire is provided upon request only and is available when the ride begins until 45 minutes after the ride is complete.</li> <li>➤ <b>Capacity:</b> 30 adults per wagon, 20 adults per sleigh.</li> </ul>	<p style="text-align: center;"><b>CANCELLATION POLICY</b></p> <ul style="list-style-type: none"> <li>◆ All cancellations must be made at least one week in advance of the scheduled ride in order to receive a refund, less \$15 administration fee, or to reserve an alternative date. Contact Danada @ 630-668-6012.</li> <li>◆ In the event of inclement weather, the Equestrian Center staff will consult with the group's contact person and arrangements will be made as circumstances require.</li> <li>◆ Hayrides will automatically be canceled in the event of an electrical storm, tornado or high winds that could pose a threat to participants safety.</li> <li>◆ Rides will be canceled when thermometer or wind chill temperatures drop below 0° F. Note: Rides will continue when there is light drizzle combined with temperatures of 55 ° F or higher.</li> <li>◆ Sleigh rides require a minimum of six (6") inches of packed snow base.
