Contact Danada @ 630-668-6012. ◆ In the event of inclement weather, the Equestrian Center staff will consult with the group's contact person and arrangements will be made as circumstances require. ◆ Hayrides will automatically be canceled in the event of an electrical storm, tornado or high winds that could pose a threat to participants safety. ◆ Rides will be canceled when thermometer or wind chill temperatures drop below 0° F. Note: Rides will continue when there is light drizzle combined with temperatures of 55 ° F or higher. ◆ Sleigh rides require a minimum of six (6") inches of packed snow base.
